CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

CINDER BUTTE INC.

confirms the right to use the waters of THREE WELLS in the MALHEUR SLOUGH BASIN for the purpose of PRIMARY IRRIGATION OF 445.1 ACRES AND SUPPLEMENTAL IRRIGATION OF 98.5 ACRES.

The right has been perfected under Permit G-8161. The date of priority is JANUARY 25, 1978. The right is limited to not more than 6.8 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the well.

The wells are located as follows:

SW 1/4 SE 1/4, SECTION 30, NW 1/4 SE 1/4, SECTION 31, SW 1/4 NW 1/4, SECTION 30, T 25 S, R 34 E, W.M.; WELL 1 - 5470 FEET NORTH AND 3140 FEET EAST; WELL 3 - 1700 FEET NORTH & 2790 FEET EAST, BOTH FROM SOUTHWEST CORNER SECTION 31; WELL 5 - 1530 FEET SOUTH AND 600 FEET EAST FROM NORTHWEST CORNER SECTION 30.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
