CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of AN UNNAMED STREAM AND RESERVOIR CONSTRUCTED UNDER PERMIT R-4775, a tributary of WEST FORK DAIRY CREEK, for the purpose of IRRIGATING 126.6 ACRES.

The right has been perfected under Permit 43390. The date of priority is JULY 18, 1978. The right is limited to not more than 0.93 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SW 1/4 NE 1/4, AS PROJECTED WITHIN DLC 52, SECTION 11,
T 1 N, R 4 W, W.M.; 2260 FEET SOUTH AND 2250 FEET WEST FROM NE CORNER
DLC 52.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage. Water shall not be appropriated during the period from July 31 through September 15 of each year except from stored water.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

NE 1/4 NE 1/4 13.2 ACRES
NW 1/4 NE 1/4 28.9 ACRES
SW 1/4 NE 1/4 25.3 ACRES
SE 1/4 NE 1/4 36.4 ACRES
NE 1/4 NW 1/4 15.7 ACRES
ALL AS PROJECTED WITHIN DLC 52
SECTION 11

SW 1/4 NW 1/4 7.1 ACRES
SECTION 12
TOWNSHIP 1 NORTH, RANGE 4 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
