CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

WILLIAM E. AND SUE ALLEN COX
3400 GARDEN VALLEY ROAD
ROSEBURG, OREGON 97470

confirms the right to use the waters of CAMAS SWALE CREEK, a tributary of NORTH UMPQUA RIVER, for the purpose of IRRIGATING 11.38 ACRES AND LIVESTOCK USE.

The right has been perfected under Permit 43490. The date of priority is AUGUST 8, 1978. The right is limited to not more than 0.145 CUBIC FOOT PER SECOND; BEING 0.14 CFS FOR IRRIGATION AND 0.005 CFS FOR STOCK, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NW 1/4 NW 1/4, AS PROJECTED WITHIN DLC 49, SECTION 13, T 26 S, R 6 W, W.M.; 860 FEET SOUTH AND 690 FEET EAST FROM NW CORNER SECTION 13.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
