## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

CAMPBELL WATER CORP. P.O. BOX 378 WOODBURN, OREGON 97071

confirms the right to use the waters of TWO WELLS in the LITTLE PUDDING RIVER BASIN for the purpose of DOMESTIC USE FOR 116 FAMILIES AND IRRIGATION OF LAWNS AND GARDENS FOR 296 FAMILIES.

The right has been perfected under Permit G-8107. The date of priority is MAY 2, 1978. The right is limited to not more than 0.45 CUBIC FOOT PER SECOND FROM WELL 1 WHEN AVALABLE WITH ANY DEFICIENCY IN THE AVAILABLE SUPPLY TO BE MADE UP BY APPROPRIATION FROM WELL 2 PROVIDED THAT THE TOTAL QUANTITY DIVERTED FROM BOTH WELLS SHALL NOT EXCEED 0.45 CFS; BEING 0.25 CFS FOR DOMESTIC USE FOR 116 FAMILIES AND 0.2 CFS FOR IRRIGATION OF LAWNS AND GARDENS NOT TO EXCEED 0.21 ACRE PER FAMILY, or its equivalent in case of rotation, measured at the wells.

The wells are located as follows:

NW 1/4 NW 1/4, AS PROJECTED WITHIN DLC 71, SECTION 8, T 7 S, R 2 W, W.M.; WELL 1 - 950 FEET SOUTH & 1150 FEET EAST; WELL 2-160 FEET SOUTH & 840 FEET EAST BOTH FROM NW CORNER SECTION 8.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
