CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ROBERT S. NELSON

JUNCTION CITY, OREGON 97448

confirms the right to use the waters of THE LONG TOM RIVER AND FERN RIDGE RESERVOIR CONSTRUCTED UNDER PERMIT R-1625, a tributary of THE WILLAMETTE RIVER, for the purpose of IRRIGATING 206.2 ACRES.

The right has been perfected under Permit 38037. The date of priority is OCTOBER 30, 1974. The right is limited to not more than 0.87 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the points of diversion from the source.

The points of diversion are located as follows:

NE 1/4 NW 1/4, NW 1/4 SE 1/4, BOTH AS PROJECTED WITHIN DLC 55, SECTION 10, T 16 S, R 5 W, W.M.; DIVERSION 1-710 FEET SOUTH AND 510 FEET EAST FROM NW CORNER DLC 55, DIVERSION 2-1050 FEET NORTH AND 490 FEET WEST FROM SE CORNER DLC 55.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre from direct flow, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage and is subject to the terms and conditions of Contract No. 14-06-100-7775, or a satisfactory replacement, between the Bureau of Reclamation and the applicant, a copy of which is on file in the records of the Water Resources Department.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
