CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

PHILLIP H. GOULET

confirms the right to use the waters of DEEP LAKE, a tributary of WILLAMETTE RIVER, for the purpose of IRRIGATING 76.5 ACRES.

The right has been perfected under Permit 43640. The date of priority is JUNE 10, 1977. The right is limited to not more than 0.96 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

SE 1/4 NE 1/4, NE 1/4 SE 1/4, BOTH AS PROJECTED WITHIN DLC 38, SECTION 2, T 6 S, R 3 W, W.M.; 970 FEET SOUTH AND 1280 FEET EAST, 2240 FEET SOUTH AND 1170 FEET EAST, BOTH FROM MOST NORTHERLY CORNER DLC 38.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
