CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters FROM THE WILLAMETTE BASIN PROJECT RESERVOIRS, CONSTRUCTED UNDER PERMITS R-1625 AND R-5363, a tributary of THE COLUMBIA RIVER, for the purpose of THE SUPPLEMENTAL IRRIGATION OF 347.1 ACRES.

The right has been perfected under Permit 41931. The date of priority is MAY 18, 1977. The right is limited to not more than 746.3 ACRE FEET or its equivalent in case of rotation, measured at the points of diversion from the source.

The points of diversion are located as follows:

SE 1/4 SW 1/4, AS PROJECTED WITHIN DLC 50, SECTION 11, LOT 3(SW 1/4 NE 1/4), SECTION 14, T 10 S, R 4 W, W.M.; DIVERSION POINT 1-120 FEET SOUTH AND 4240 FEET EAST FROM SE CORNER DLC 69, DIVERSION POINT 2-3380 FEET NORTH AND 3570 FEET EAST FROM SW CORNER SECTION 14.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year and is subject to the terms and conditions of Contract Nos. 7-07-10-W0014, 7-07-10-W0017, and 7-07-10-W0018, or a satisfactory replacement, between the Bureau of Reclamation and the applicant, a copy of which is on file in the records of the Water Resources Department.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
