CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of AN UNNAMED STREAM AND PLUNKETT CREEK, tributaries of LUCKIAMUTE RIVER, for the purpose of IRRIGATING 4.0 ACRES.

The right has been perfected under Permit 43818. The date of priority is SEPTEMBER 5, 1978. The right is limited to not more than 0.051 CUBIC FOOT PER SECOND; BEING 0.018 CFS FROM UNNAMED STREAM AND 0.033 CFS FROM PLUNKETT CREEK, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

SE 1/4 NE 1/4, SECTION 32, SE 1/4 NW 1/4, SECTION 33, BOTH AS PROJECTED WITHIN DLC 38, T 10 S, R 6 W, W. M.; UNNAMED STREAM - 100 FEET SOUTH AND 550 FEET EAST; PLUNKETT CREEK - 220 FEET SOUTH AND 2350 FEET EAST; BOTH FROM NW CORNER DLC 38.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
