CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of AN UNNAMED STREAM AND ELK CREEK, a tributary of WINCHUCK RIVER, for the purpose of IRRIGATING 4.8 ACRES, LIVESTOCK, AND DOMESTIC USE FOR TWO FAMILIES.

The right has been perfected under Permit 44912. The date of priority is MAY 18, 1979. The right is limited to not more than 0.075 CUBIC FOOT PER SECOND; BEING 0.01 CFS FOR IRRIGATION, 0.005 CFS FOR LIVESTOCK AND 0.01 CFS FOR DOMESTIC FROM UNNAMED STREAM AND 0.05 CFS FROM ELK CREEK FOR IRRIGATION or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

NW 1/4 SE 1/4, SW 1/4 SE 1/4, SECTION 9, T 41 S, R 12 W, W.M.; UNNAMED STREAM - 100 FEET SOUTH AND 3050 FEET EAST; ELK CREEK - 1540 FEET SOUTH AND 3100 FEET EAST, BOTH FROM WEST 1/4 CORNER SECTION 9.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
