CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

KENNETH L. AND JULIA A. GREEN KELLOGG STAR ROUTE, BOX 15-A OAKLAND, OREGON 97462

confirms the right to use the waters of CALAPOOYA CREEK, a tributary of UMPQUA RIVER, for the purpose of IRRIGATING 33.9 ACRES AND STOCKWATER.

The right has been perfected under Permit 47104. The date of priority is SEPTEMBER 7, 1982. The right is limited to not more than 0.33 CUBIC FOOT PER SECOND, BEING 0.32 CFS FOR IRRIGATION AND 0.01 CFS FOR STOCK, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NW 1/4 NW 1/4, AS PROJECTED WITHIN DLC 55, SECTION 8, T 25 S, R 5 W, W.M.; 420 FEET SOUTH AND 75 FEET EAST FROM NW CORNER SECTION 8.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE- EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

This certificate is issued to correctly describe the place of use and supersedes Certificate recorded at page 60663, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
