CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of TEAL CREEK, a tributary of LITTLE LUCKIAMUTE RIVER, for the purpose of IRRIGATING 31.1 ACRES.

The right has been perfected under Permit 30319. The date of priority is MARCH 24, 1965. The right is limited to not more than 0.39 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

NE 1/4 SE 1/4, SE 1/4 SE 1/4, BOTH AS PROJECTED WITHIN DLC 46, SECTION 27, T 8 S, R 6 W, W.M.; 1640 FEET SOUTH AND 1160 FEET WEST, 1352 FEET SOUTH AND 1740 FEET WEST, 1710 FEET SOUTH AND 770 FEET WEST, ALL FROM NW CORNER DLC 43.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

SE 1/4 NE 1/4        1.3 ACRES  
NE 1/4 SE 1/4       14.6 ACRES  
SE 1/4 SE 1/4       15.2 ACRES  
ALL AS PROJECTED WITHIN DLC 46  
SECTION 27  
TOWNSHIP 8 SOUTH, RANGE 6 WEST, W.M.

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered DECEMBER 20, 1984, and supersedes certificate 34199, State Record of Water Right Certificates. The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
