CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

WAYNE AND LORENE PEARSON
ROUTE 4, BOX 351
COOS BAY, OREGON 97420

confirms the right to use the waters of EAST FORK COQUILLE RIVER, A SPRING, AND AN UNNAMED STREAM, tributaries of NORTH FORK COQUILLE RIVER, for the purpose of IRRIGATING 2.0 ACRES AND DOMESTIC USE FOR ONE FAMILY.

The right has been perfected under Permit 46372. The date of priority is MARCH 2, 1981. The right is limited to not more than 0.03 CUBIC FOOT PER SECOND; BEING 0.025 CFS FROM EAST FORK COQUILLE RIVER FOR IRRIGATION AND 0.005 CFS FROM SPRING WITH ANY DEFICIENCY IN SUPPLY AT THE SPRING TO BE MADE UP BY DIVERSION OF WATER FROM THE UNNAMED STREAM FOR DOMESTIC USE or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

NW 1/4 NE 1/4, SE 1/4 NW 1/4, SECTION 13, T 28 S, R 11 W, W.M.; RIVER - 40 FEET SOUTH AND 200 FEET EAST, SPRING - 1630 FEET SOUTH AND 390 FEET WEST, STREAM - 2060 FEET SOUTH AND 60 FEET WEST, ALL FROM N 1/4 CORNER SECTION 13.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

NW 1/4 NE 1/4 2.0 ACRES AND DOMESTIC
SECTION 13
TOWNSHIP 28 SOUTH, RANGE 11 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
