CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ARLENE L. KOVASH 11425 PEDEE CREEK ROAD MONMOUTH, OREGON 97361

confirms the right to use the waters of A SPRING AND SOUTH FORK PEDEE CREEK, tributaries of PEDEE CREEK, for the purpose of IRRIGATING 29.4 ACRES, LIVESTOCK AND DOMESTIC USE FOR TWO FAMILIES INCLUDING THE IRRIGATION OF NON-COMMERCIAL LAWN AND GARDEN NOT TO EXCEED ONE-HALF ACRE.

The right has been perfected under Permit 46373. The date of priority is MARCH 3, 1981. The right is limited to not more than 0.235 CUBIC FOOT PER SECOND; BEING 0.22 CFS FROM SOUTH FORK PEDEE CREEK FOR IRRIGATION, 0.01 CFS FROM THE SPRING FOR DOMESTIC USE, AND 0.005 CFS FROM SPRING FOR LIVESTOCK, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversions are located as follows:

NE 1/4 SW 1/4, LOT 1 (SW 1/4 SW 1/4), SECTION 20, T 9 S, R 6 W, W.M.; SPRING - 160 FEET SOUTH AND 50 FEET WEST, CREEK - 880 FEET NORTH AND 1390 FEET EAST, BOTH FROM NW CORNER DLC 51.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

SECTION 20

NE 1/4 NW 1/4 23.7 ACRES
SE 1/4 NW 1/4 1.6 ACRES
BOTH AS PROJECTED WITHIN DLC 51
SECTION 29
TOWNSHIP 9 SOUTH, RANGE 6 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
