and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 8 , at page 1 : that the priority of the right thereby confirmed dates from 1880

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed Three acre feet per acre in any irrigation season, diverted at a rate of not to exceed one-fortieth of a cubic foot per second per acre.

A description of the lands irrigated under such which to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:

Thirty-six (36) acres in the Northeast Quarter of the Northwest Quarter (NEZNYZ), Forty (40) acres in the Northwest Quarter of the Northwest Quarter (NW2-NW4), Forty (40) acres in the Southwest Quarter of the Northwest Quarter (SW4NW4) Sixteen (16) acres in the Southeast Quarter of the Northwest Quarter (SEINW1) Section Thirty (30): Forty (40) acres in the Northeast Quarter of the Southwest Quarter (NE2SW2), Forty (40) acres in the Southeast Quarter of the Southwest Quarter (SE2SW2), Forty (40) acres in the Southwest Quarter of the Southwest Quarter (SW2SW2), Forty (40) acres in the Northwest Quarter of the Southwest Quarter (NW4SW4), Nineteen (19) acres in the Northwest Quarter of the Southeast Quarter (NW4SE4), Twelve (12) acres in the Southwest Quarter of the Southeast Quarter (SW2SE2), Section Nineteen (19), Township 3 South, Range 40 East of the Willamette Meridian, being a total of 323 acres.

(NOTE: This land was irrigated from the overflow of Catherine Creek near its mouth and from the waste water from irrigation ditches taken from Little Creek and Catherine Creek near the mouth of the canyon and has never used water after the 1st of July of each year and this right is limited to an irrigation season ending with July 1st of each year; this land also has a supplemental supply under State Engineer's Permit No. 765 which right shall be in accordance with the laws governing the same.

And said right shall be subject to all other conditions and limitations contained in said decree.

The right to the use of the water for irrigation purposes is restricted to the lands or place of use herein described.
