CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

CLARENCE BUHLER

confirms the right to use the waters of SALT CREEK AND BUHLER FLASHBOARD DAM RESERVOIR CONSTRUCTED UNDER PERMIT R-8184, a tributary of SOUTH YAMHILL RIVER, for the purpose of IRRIGATING 54.0 ACRES.

The right has been perfected under Permit 45199. The date of priority is SEPTEMBER 15, 1980. The right is limited to not more than 0.68 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SW 1/4 NW 1/4, AS PROJECTED WITHIN DLC 58, SECTION 32, T 6 S, R 5 W, W.M.; 1500 FEET SOUTH AND 900 FEET EAST FROM NW CORNER SECTION 32.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
