CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of WELL # 3 in the COLUMBIA RIVER BASIN for the purpose of SUPPLEMENTAL IRRIGATION OF 273.6 ACRES.

The right has been perfected under Permit G-9825. The date of priority is JUNE 25, 1982. The right is limited to not more than 1.78 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

SW 1/4 NW 1/4, SECTION 10, T 4 N, R 29 E, W.M.; 1200 FEET NORTH AND 1420 FEET WEST FROM CENTER 1/4 CORNER, SECTION 10.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. The right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

SW 1/4 NW 1/4	33.5 ACRES
NE 1/4 SW 1/4	34.1 ACRES
NW 1/4 SW 1/4	32.9 ACRES
SW 1/4 SW 1/4	35.1 ACRES
SE 1/4 SW 1/4	34.5 ACRES
NW 1/4 SE 1/4	34.1 ACRES
SW 1/4 SE 1/4	34.7 ACRES
SE 1/4 SE 1/4	34.7 ACRES

TOWNSHIP 4 NORTH, RANGE 29 EAST, W.M.

This certificate is issued to correctly describe the quantity of water and supercedes certificate 61397, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
