CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of MCBEE LAKE, a tributary of WILLAMETTE RIVER, for the purpose of PRIMARY IRRIGATION OF 23.4 ACRES AND SUPPLEMENTAL IRRIGATION OF 21.7 ACRES.

The right has been perfected under Permit 44671. The date of priority is OCTOBER 17, 1979. The right is limited to not more than 0.56 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NW 1/4 NE 1/4, AS PROJECTED WITHIN DLC 44, SECTION 11, T 13 S, R 5 W, W.M.; 250 FEET SOUTH AND 1340 FEET WEST FROM SW CORNER DLC 45.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year. Although declared herein to be for supplemental irrigation, the right allowed may, in the interest of conserving the ground water supplies, be exercised at times when water is available in the ground water supply provided that the total quantity diverted from all sources of supply does not exceed the limitation allowed herein.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

TOWNSHIP 13 SOUTH, RANGE 5 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
