CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of AN UNNAMED STREAM AND RESERVOIR CONSTRUCTED UNDER PERMIT R-3290 WITH ANY DEFICIENCY IN THE AVAILABLE SUPPLY TO BE APPROPRIATED FROM ABIQUA CREEK for the purpose of PRIMARY IRRIGATION OF 22.2 ACRES, and the waters of ABIQUA CREEK for the purpose of SUPPLEMENTAL IRRIGATION OF 46.6 ACRES. All sources are tributary to PUDDING RIVER.

The right has been perfected under Permit 46542. The date of priority is APRIL 12, 1982. The right is limited to not more than 0.86 CUBIC FOOT PER SECOND; BEING 0.28 CFS FROM THE UNNAMED STREAM AND RESERVOIR AND 0.58 CFS FROM ABIQUA CREEK, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

NW 1/4 NW 1/4, NW 1/4 SE 1/4, SECTION 22, T 6 S, R 1 W, W.M.; STREAM AND RESERVOIR - 360 FEET SOUTH AND 860 FEET EAST FROM NW CORNER SECTION 22, ABIQUA CREEK - 1230 FEET SOUTH AND 200 FEET EAST FROM C 1/4 CORNER, SECTION 22.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage. The right shall be limited to any deficiency in the available supply of any prior right for the same land and shall not exceed the limitation allowed herein.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
