CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of 2 WELLS in the HOEKSTRE SLOUGH BASIN for the purpose of SUPPLEMENTAL IRRIGATION OF 15.0 ACRES.

The right has been perfected under Permit G-9822. The date of priority is JUNE 18, 1982. The right is limited to not more than 0.06 CUBIC FOOT PER SECOND; BEING 0.03 CFS FROM EACH WELL, or its equivalent in case of rotation, measured at the wells.

The wells are located as follows:

SW 1/4 SE 1/4, AS PROJECTED WITHIN DLC 40, SECTION 9, NE 1/4 NE 1/4, AS PROJECTED WITHIN DLC 40, SECTION 16, T 7 S, R 5 W, W.M.; WELL 2 - 300 FEET NORTH AND 2040 FEET WEST, WELL 1 - 90 FEET SOUTH AND 1230 FEET WEST BOTH FROM NE CORNER SECTION 16.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year. The right shall be limited to any deficiency in the available supply of any prior right for the same land and shall not exceed the limitation allowed herein and shall be further limited to appropriation of water only to the extent that it does not impair or substantially interfere with existing surface water rights of others.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

TOWNSHIP 7 SOUTH, RANGE 5 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
