## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of 3 WELLS in the LONG TOM RIVER BASIN for the purpose of IRRIGATING 194.1 ACRES.

The right has been perfected under Permit G-9868. The date of priority is JUNE 16, 1980, FOR 1.0 CFS AND SEPTEMBER 22, 1982, FOR 1.43 CFS. The right is limited to not more than 2.43 CUBIC FEET PER SECOND, BEING 1.95 CFS FROM FROM WELL 1, 0.45 CFS FROM WELL 2 AND 0.03 CFS FROM WELL 3, or its equivalent in case of rotation, measured at the well.

The wells are located as follows:

SE 1/4 SW 1/4, AS PROJECTED WITHIN DLC 44, NE 1/4 SE 1/4, LOT 5 (SE 1/4 SE 1/4), SECTION 10, T 14 S, R 5 W, W.M.; WELL 2-470 FEET NORTH AND 1200 FEET WEST; WELL 1-1570 FEET NORTH AND 1000 FEET EAST; WELL 3-40 FEET NORTH AND 2200 FEET EAST, ALL FROM NW COR DLC

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.
