CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JERRY DEAN COE
5509 KANE CREEK ROAD
CENTRAL POINT, OREGON 97501

confirms the right to use the waters of SPRINGS 1, 2, AND 3, tributaries of KANE CREEK, for the purposes of DOMESTIC USE FOR ONE FAMILY, STOCK USE, AND IRRIGATING 2.0 ACRES.

The right has been perfected under Permit 36979. The date of priority is JUNE 9, 1972. The right is limited to not more than 0.035 CUBIC FOOT PER SECOND; BEING 0.005 CFS FOR DOMESTIC AND 0.005 CFS FOR STOCK FROM SPRING 1, AND 0.025 CFS FOR IRRIGATION FROM SPRING 2 WITH ANY DEFICIENCY IN THE AVAILABLE SUPPLY FROM SPRING 2 TO BE MADE UP BY APPROPRIATION FROM SPRINGS 1 AND 3 PROVIDED THAT THE TOTAL QUANTITY DIVERTED FROM ALL SOURCES FOR IRRIGATION SHALL NOT EXCEED 0.025 CFS, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

SE 1/4 SE 1/4, SECTION 34, T 36 S, R 3 W, W.M.; SPRING 1-1090 FEET NORTH AND 960 FEET WEST, SPRING 2 - 950 FEET NORTH AND 980 FEET WEST, SPRING 3 - 980 FEET NORTH AND 1040 FEET WEST ALL FROM SE CORNER SECTION 34.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

SE 1/4 SE 1/4 2.0 ACRES, DOMESTIC, AND STOCK
SECTION 34
TOWNSHIP 36 SOUTH, RANGE 3 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
