confirms the right to use the waters of AN UNNAMED STREAM AND WEST FORK DEADWOOD CREEK, tributaries of DEADWOOD CREEK, for the purposes of DOMESTIC USE FOR ONE FAMILY AND THE IRRIGATION OF 20.0 ACRES.

The right has been perfected under Permit 40840. The date of priority is MARCH 15, 1976. The right is limited to not more than 0.255 CUBIC FOOT PER SECOND; BEING 0.005 CFS FROM THE UNNAMED STREAM FOR DOMESTIC AND 0.25 CFS FROM DEADWOOD CREEK FOR IRRIGATION, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

SW 1/4 SW 1/4, SECTION 14, NW 1/4 NW 1/4, SW 1/4 NW 1/4, NW 1/4 SW 1/4, SECTION 23, T 16 S, R 9 W, W.M.; WEST FORK DEADWOOD CREEK - PORTABLE PUMPING BETWEEN POINTS - 640 FEET NORTH AND 1270 FEET EAST AND 3920 FEET SOUTH AND 780 FEET EAST BOTH FROM NW CORNER SECTION 23, UNNAMED STREAM - 950 FEET SOUTH AND 210 FEET EAST FROM NW CORNER SECTION 23.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
