CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ALVIN WEIRICH  
13625 SOUTH EAST STATION ROAD

confirms the right to use the waters of SOUTH YAMHILL RIVER, a tributary of YAMHILL RIVER, for the purpose of IRRIGATING 11.0 ACRES AND SUPPLEMENTAL IRRIGATION OF 22.6 ACRES.

The right has been perfected under Permit 48753. The date of priority is JULY 19, 1984. The right is limited to not more than 0.23 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SE 1/4 SE 1/4, AS PROJECTED WITHIN DLC 40, SECTION 5, T 5 S R 4 W, W.M.; 1200 FEET NORTH AND 470 FEET WEST FROM SE CORNER SECTION 5.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
