## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

BAILEY NURSERIES, INCORPORATED 9855 NW PIKE ROAD YAMHILL, OREGON 97148

confirms the right to use the waters of BRYAN CREEK AND A RESERVOIR CONSTRUCTED UNDER PERMITS R-1407, ENLARGED UNDER PERMITS R-1560 AND R-1761, a tributary of CHEHALEM CREEK, for the purpose of IRRIGATING 87.3 ACRES.

The right has been perfected under Permit 49264. The date of priority is MARCH 12, 1985. The right is limited to not more than 1.09 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

NW 1/4 SW 1/4, AS PROJECTED WITHIN DLC 41, SECTION 2, SE 1/4 NE 1/4, AS PROJECTED WITHIN DLC 45, SECTION 10, T 3 S, R 3 W, W.M.; RES - 1750 FEET NORTH AND 1240 FEET EAST; CREEK - 1950 FEET SOUTH AND 240 FEET WEST, BOTH FROM SW CORNER SECTION 2.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
