CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO  
SALMON VALLEY WATER COMPANY

WEMME, OREGON 97067

confirms the right to use the waters of A WELL in the SALMON RIVER BASIN for the purpose of THE PRIMARY IRRIGATION OF 7.6 ACRES, THE SUPPLEMENTAL IRRIGATION OF 2.4 ACRES, AND GROUP DOMESTIC USE FOR 27 FAMILIES.

The right has been perfected under Permit G-3713. The date of priority is AUGUST 24, 1967. The right is limited to not more than 0.17 CUBIC FOOT PER SECOND, BEING 0.11 CFS FOR IRRIGATION AND 0.06 CFS FOR DOMESTIC or its equivalent in case of rotation, measured at the well.

The well is located as follows:

NW 1/4 SE 1/4, SECTION 4, T 3 S, R 7 E, W.M., 3020 FEET SOUTH AND 3770 FEET EAST FROM NW CORNER SECTION 4.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

This certificate is issued so as to correctly described the place of use and supersedes certificate of water right recorded at page 44575, State Record of Water Right Certificates.

The issuance of superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
