CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

EUGENE BOWMAN
DBA: MT. HOOD GOLF CLUB
WEMME, OREGON 97067

confirms the right to use the waters of A WELL in the SALMON RIVER BASIN for the purpose of THE PRIMARY IRRIGATION OF 20.0 ACRES, GROUP DOMESTIC USE FOR 24 FAMILIES, AND COMMERCIAL USE AT A MOTEL AND RESTAURANT.

The right has been perfected under Permit G-3714. The date of priority is JUNE 9, 1967. The right is limited to not more than 0.24 CUBIC FOOT PER SECOND; BEING 0.11 CFS FOR IRRIGATION, 0.03 CFS FOR DOMESTIC, AND 0.10 CFS FOR COMMERCIAL USE, or its equivalent in case of rotation, measured at the well.

The well is located as follows:

NW 1/4 SW 1/4, SECTION 4, T 3 S, R 7 E, W.M., 3850 FEET SOUTH AND 160 FEET EAST FROM THE NW CORNER OF SECTION 4.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
