confirms the right to use the waters of TROUT CREEK, a tributary of ALVORD LAKE, for the purpose of IRRIGATING 96.8 ACRES.

The right has been confirmed by decree of the Circuit Court of the State of Oregon for HARNEY County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 3, at page 94. The date of priority is 1895.

The right is limited to not more than 2.42 CUBIC FEET PER SECOND, IF AVAILABLE AT THE ORIGINAL POINT OF DIVERSION: SE 1/4 NE 1/4 SECTION 33, T 38 S, R 35 E, W.M.

The point of diversion is located as follows:

NW 1/4 NW 1/4 SECTION 29, T 39 S, R 36 E, W.M.; 950 FEET SOUTH & 550 FEET EAST FROM NW CORNER SECTION 29.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

SE 1/4 SE 1/4 0.8 ACRE

SECTION 13

NE 1/4 NE 1/4 37.2 ACRES

NW 1/4 NE 1/4 40.0 ACRES

This certificate is issued to confirm a change in PLACE OF USE AND POINT OF DIVERSION approved by an order of the Water Resources Director entered SEPTEMBER 17, 1946.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and shall be subject to all other conditions and limitations contained in said decree.
