CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JOHN AND JEAN DEBONA ROUTE 1, BOX 282 MT. VERNON, OREGON 97865

confirms the right to use the waters of JOHN DAY RIVER, a tributary of COLUMBIA RIVER, for the purpose of IRRIGATING 6.1 ACRES.

The right has been confirmed by decree of the Circuit Court of the State of Oregon for GRANT County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 15, at page 461. The date of priority is 1885.

The right is limited to not more than ONE-FORTIETH CUBIC FOOT PER SECOND PER ACRE IRRIGATED FROM APRIL 1 TO SEPTEMBER 30; FURTHER LIMITED TO 1 ACRE-FOOT PER ACRE PER CALENDAR MONTH TO JULY 1, AND 3/4 ACRE-FOOT PER ACRE THEREAFTER; TOTAL 5 ACRE-FEET PER ACRE FOR SEASON MEASURED AT THE POINT OF DIVERSION.

The points of diversion are located as follows:

NW 1/4 SE 1/4, SECTION 13, NW 1/4 SE 1/4, SECTION 14, T 13 S, R 28 E, W.M.; 1560 FEET NORTH AND 1060 FEET EAST FROM S 1/4 CORNER, SECTION 13, 490 FEET SOUTH AND 1560 FEET WEST FROM E 1/4 CORNER, SECTION 14.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

NE 1/4 SE 1/4 4.4 ACRES
NW 1/4 SE 1/4 1.7 ACRES
SECTION 14
TOWNSHIP 13 SOUTH, RANGE 28 EAST, W.M.

(NOTE: THIS LAND HAS A SUPPLEMENTAL SUPPLY FROM FIELDS CREEK, THROUGH THE CREEK DITCH WITH A PRIORITY OF 1865.)

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered FEBRUARY 22, 1983, and together with certificate 51510, supersedes certificate 25580, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and shall be subject to all other conditions and limitations contained in said decree.
