CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

BETTI VAYNE DIONNE AND JAMES DIONNE 9100 SE STARR QUARRY ROAD AMITY, OREGON 97101

confirms the right to use the waters of SPRING 1 WITH ANY DEFICIENCY IN THE AVAILABLE SUPPLY FROM SPRING 1 TO BE MADE UP BY APPROPRIATION FROM SPRING 2, tributaries of YAMHILL RIVER, for the purpose of IRRIGATING 2.1 ACRES AND LIVESTOCK.

The right has been perfected under Permit 43298. The date of priority is JANUARY 26, 1978. The right is limited to not more than 0.035 CUBIC FOOT PER SECOND, BEING 0.03 CFS FOR IRRIGATION AND 0.005 CFS FOR LIVESTOCK, or its equivalent in case of rotation, measured at the point of diversion from the source.

The springs are located as follows:

SW 1/4 NE 1/4, SE 1/4 NW 1/4, BOTH AS PROJECTED WITHIN DLC 54, SECTION 14, T 5 S, R 4 W, W.M.; SPRING 1 - 1920 FEET SOUTH AND 2500 FEET WEST; SPRING 2 - 1990 FEET SOUTH AND 2700 FEET WEST, BOTH FROM NE CORNER SECTION 14.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

SE 1/4 SW 1/4 LIVESTOCK AS PROJECTED WITHIN DLC 52 SECTION 11

NE 1/4 NW 1/4 0.3 ACRE AS PROJECTED WITHIN DLC 54 NE 1/4 NW 1/4 1.8 ACRES AS PROJECTED WITHIN DLC 52 SECTION 14

TOWNSHIP 5 SOUTH, RANGE 4 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
