## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

RALPH HOWELL 11998 TOWERS ROAD SE STAYTON, OREGON 97383

confirms the right to use the waters of AN UNNAMED STREAM, NORTH SANTIAM RIVER AND RESERVOIR CONSTRUCTED UNDER PERMIT R-8099, tributaries of SANTIAM RIVER, for the purpose of IRRIGATING 1.0 ACRE AND RECREATION.

The right has been perfected under Permit 44725. The date of priority is JUNE 19, 1979. The right is limited to not more than 0.03 CUBIC FOOT PER SECOND; BEING 0.01 CFS FROM THE UNNAMED STREAM FOR IRRIGATION AND 0.02 CFS FROM NORTH SANTIAM RIVER TO MAINTAIN THE RESERVOIR FOR RECREATION, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

LOT 1 (NE 1/4 NE 1/4), SECTION 21, LOT 4 (NW 1/4 NW 1/4), SECTION 22, T 9 S, R 1 E, W.M.; UNNAMED STREAM - 600 FEET SOUTH AND 440 FEET EAST, RIVER - 1040 FEET SOUTH AND 1550 FEET EAST, BOTH FROM NW CORNER, LOT 1 (NE 1/4 NE 1/4), SECTION 21.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

LOT 1 (NE 1/4 NE 1/4) 1.0 ACRE AND RECREATION SECTION 21
TOWNSHIP 9 SOUTH, RANGE 1 EAST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
