CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

C.S. AND LENA ANDERSON, ANN AND HOLLIS MAST
2470 FAIRVIEW ROUTE
COQUILLE, OREGON 97423

confirms the right to use the waters of NORTH FORK COQUILLE RIVER AND AN UNNAMED CREEK, a tributary of COQUILLE RIVER, for the purpose of IRRIGATING 14.7 ACRES AND DOMESTIC USE FOR ONE FAMILY.

The right has been perfected under Permit 37960. The date of priority is APRIL 3, 1973. The right is limited to not more than 0.185 CUBIC FOOT PER SECOND; BEING 0.18 CFS FROM RIVER FOR IRRIGATION AND 0.005 CFS FROM CREEK FOR DOMESTIC, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

SW 1/4 SW 1/4, SECTION 12, LOT 1 (NW 1/4 NW 1/4), SECTION 13, T 28 S, R 12 W, W.M.; CREEK - 150 FEET NORTH AND 1000 FEET WEST, RIVER - 500 FEET SOUTH AND 700 FEET WEST, BOTH FROM NE CORNER LOT 1 (NW 1/4 NW 1/4), SECTION 13.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

SW 1/4 SW 1/4 2.3 ACRES
SECTION 12

LOT 1 (NW 1/4 NW 1/4) 12.4 ACRES AND DOMESTIC
SECTION 13
TOWNSHIP 28 SOUTH, RANGE 12 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
