CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

GLEN E. LEWIS BOX 205 SOUTH MYRTLE ROUTE MYRTLE CREEK, OREGON 97457

confirms the right to use the waters of AN UNNAMED STREAM AND SOUTH MYRTLE CREEK, tributaries of SOUTH UMPQUA RIVER, for the purpose of IRRIGATING 6.6 ACRES AND LIVESTOCK.

The right has been perfected under Permit 44019. The date of priority is AUGUST 9, 1978, FOR 0.07 CFS AND APRIL 9, 1979, FOR 0.015 CFS. The right is limited to not more than 0.085 CUBIC FOOT PER SECOND; BEING 0.005 CFS FROM THE UNNAMED STREAM FOR LIVESTOCK, 0.03 CFS FROM THE UNNAMED STREAM WITH ANY DEFICIENCY IN THE AVAILABLE SUPPLY TO BE MADE UP BY DIVERSION FROM SOUTH MYRTLE CREEK AND 0.05 CFS FROM SOUTH MYRTLE CREEK FOR IRRIGATION, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

SW 1/4 NW 1/4, SECTION 29, T 29 S, R 4 W, W.M.; SOUTH MYRTLE CREEK - 450 FEET SOUTH AND 470 FEET WEST; UNNAMED STREAM - 950 FEET SOUTH AND 180 FEET WEST, 750 FEET SOUTH AND 180 FEET WEST; ALL FROM NE CORNER SW 1/4 NW 1/4, SECTION 29.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

UNNAMED STREAM

SOUTH MYRTLE CREEK

SW 1/4 NW 1/4 2.2 ACRES AND LIVESTOCK 4.0 ACRES SECTION 29
TOWNSHIP 29 SOUTH, RANGE 4 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
