CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

VERNE K. COOPERRIDER
ROUTE 3, BOX 15
McMINNVILLE, OREGON 97128

confirms the right to use the waters of DEER CREEK, a tributary of YAMHILL RIVER, for the purpose of IRRIGATING 57.6 ACRES.

The right has been perfected under Permit 45983. The date of priority is MAY 1, 1981. The right is limited to not more than 0.72 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NE 1/4 SE 1/4, AS PROJECTED WITHIN DLC 53, SECTION 30, T 5 S, R 5 W, W.M.; 1500 FEET NORTH AND 550 FEET WEST FROM SE CORNER SECTION 30.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

AS PROJECTED WITHIN DLC 56

SE 1/4 SE 1/4 6.1 ACRES
ALL AS PROJECTED WITHIN DLC 53

SE 1/4 SE 1/4 0.6 ACRE
AS PROJECTED WITHIN DLC 56
SECTION 30
TOWNSHIP 5 SOUTH, RANGE 5 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
