CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of THE PUDDING RIVER AND D.K.K. RESERVOIR CONSTRUCTED UNDER PERMIT R-3984, a tributary of THE MOLALLA RIVER, for the purpose of THE PRIMARY IRRIGATION OF 28.0 ACRES AND THE SUPPLEMENTAL IRRIGATION OF 103.3 ACRES.

The right has been perfected under Permit 29752. The date of priority is JULY 20, 1964. The right is limited to not more than 0.63 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

SW 1/4 NW 1/4, LOT 1 (NE 1/4 SW 1/4), SW 1/4 SE 1/4, SECTION 5, T 7 S, R 1 W, W.M.; DIVERSION 1 (DAM) - 90 FEET NORTH AND 4080 FEET WEST, DIVERSION 2 - 500 FEET SOUTH AND 3520 FEET WEST, DIVERSION 3 - 1780 FEET SOUTH AND 2510 FEET WEST, DIVERSION 4 - 730 FEET SOUTH AND 3200 FEET WEST ALL FROM E 1/4 CORNER SECTION 5.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage and is subject to the terms and conditions of an agreement recorded at pages 627 and 628, Volume 4, Miscellaneous Records of the Water Resources Department.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
