CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

EARL KENNEL 10705 AIRLIE ROAD MONMOUTH, OREGON 97361

confirms the right to use the waters of KENNEL RESERVOIR CONSTRUCTED UNDER PERMIT R-6480, a tributary of SOAP CREEK, for the purpose of IRRIGATING 159.9 ACRES.

The right has been perfected under Permit 40594. The date of priority is JULY 8, 1976. The right is limited to not more than 122 ACRE FEET OF STORED WATER ONLY.

The point of diversion is located as follows:

NE 1/4 NW 1/4, AS PROJECTED WITHIHN DLC 64, SECTION 36, T 9 S, R 5 W, W.M.; 240 FEET SOUTH AND 2150 FEET EAST FROM NW CORNER SECTION 36.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
