CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

AARON J. SCHEER

confirms the right to use the waters of A SPRING AREA AND RESERVOIR CONSTRUCTED UNDER PERMIT R-7706 AND DEER CREEK, tributaries of ILLINOIS RIVER, for the purpose of PRIMARY IRRIGATION OF 4.7 ACRES AND SUPPLEMENTAL IRRIGATION OF 6.0 ACRES.

The right has been perfected under Permit 43539. The date of priority is JUNE 19, 1978. The right is limited to not more than 0.16 CUBIC FOOT PER SECOND; BEING 0.08 CFS FROM DEER CREEK AND 0.08 CFS FROM SPRING AND RESERVOIR, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

SE 1/4 SW 1/4, SECTION 11, T 38 S, R 8 W, W.M.; SPRING AND RESERVOIR - 300 FEET NORTH AND 1100 FEET WEST, DEER CREEK - 350 FEET NORTH AND 1230 FEET WEST, BOTH FROM S 1/4 CORNER SECTION 11.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FIFTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 3.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, from direct flow and storage. The right shall be limited to any deficiency in the available supply of any prior right for the same land and shall not exceed the limitation allowed herein.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

SE 1/4 SW 1/4 SECTION 11 TOWNSHIP 38 SOUTH, RANGE 8 WEST, W.M.	4.7 ACRES	6.0 ACRES

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
