confirms the right to use the waters of SPRINGS 1, 2, 3, 4 AND 5, tributaries of NORTH FORK DALY CREEK, for the purpose of STOCK USE.

The right has been perfected under Permit 45653. The date of priority is JUNE 17, 1980. The right is limited to not more than 8.17 GALLONS PER MINUTE; BEING 4.0 GPM FROM SPRING 1, 0.67 GPM FROM SPRING 2, 1.0 GPM FROM SPRING 3, 1.5 GPM FROM SPRING 4, 1.0 GPM FROM SPRING 5, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

NE 1/4 SE 1/4, SECTION 32; NE 1/4 SE 1/4, SECTION 20; SW 1/4 NW 1/4, NE 1/4 NW 1/4, SECTION 27; NW 1/4 NE 1/4, SECTION 26, T 10 S, 45 E, W.M.; SPRING 1 - 250 FEET SOUTH & 140 FEET WEST FROM E 1/4 CORNER SECTION 32; SPRING 2 - 1500 FEET NORTH AND 300 FEET WEST FROM SE CORNER SECTION 20; SPRING 3 - 550 FEET SOUTH, SPRING 4 - 460 FEET NORTH AND 1770 FEET EAST BOTH FROM NW CORNER, SW 1/4 NW 1/4, SECTION 27; SPRING 5 - 380 FEET SOUTH AND 260 FEET EAST FROM N 1/4 CORNER SECTION 26.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
