CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

E. W. WRIGHT

confirms the right to use the waters of EAST FORK ILLINOIS RIVER, a tributary of ILLINOIS RIVER, for the purpose of IRRIGATING 62.7 ACRES.

The right has been confirmed by decree of the Circuit Court of the State of Oregon for JOSEPHINE County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 13, at page 70. The date of priority is MAY, 1887.

The right is limited to not more than 1.254 CUBIC FEET PER SECOND.

The point of diversion is located as follows:

SE 1/4 NW 1/4, SECTION 27, T 39 S, R 8 W, W.M.; 1650 FEET SOUTH & 1800 FEET EAST FROM NW CORNER SECTION 27.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FIFTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated during the irrigation season from April 1 to November 1 of each year.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

This certificate describes that portion of the water right confirmed by certificate 31667, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered JUNE 21, 1989, approving transfer application 6153.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and shall be subject to all other conditions and limitations contained in said decree.
