confirms the right to use the waters of 3 WELLS in the LAKE CREEK BASIN for the purpose of IRRIGATING 178.8 ACRES.

The right has been perfected under Permit G-6500. The date of priority is JUNE 19, 1975, FOR 1.50 CFS AND OCTOBER 22, 1975, FOR 0.74 CFS. The right is limited to not more than 2.24 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the wells.

The wells are located as follows:

NE 1/4 NW 1/4, SE 1/4 NW 1/4, BOTH AS PROJECTED WITHIN DLC 52, SECTION 18, T 12 S, R 3 W, W.M.; WELL 1 - 400 FEET SOUTH AND 1500 FEET WEST, WELL 2 - 1160 FEET SOUTH AND 1500 FEET WEST, WELL 3 - 1800 FEET SOUTH AND 1500 FEET WEST, ALL FROM THE NE CORNER OF DLC 52.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
