CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of ANIMAL WASTE AND DAIRY CLEANUP AND ANIMAL WASTE LAGOON CONSTRUCTED UNDER PERMIT R-8209, a tributary of MUDDY CREEK, for the purpose of IRRIGATING 172.9 ACRES.

The right has been perfected under Permit 45355. The date of priority is OCTOBER 1, 1980. The right is limited to not more than 0.36 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SW 1/4 SW 1/4, AS PROJECTED WITHIN DLC 37, SECTION 5, T 14 S, R 5 W, W.M.; 450 FEET NORTH AND 750 FEET EAST FROM THE SW CORNER SECTION 5.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
