CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

TIM J. MELVILLE

confirms the right to use the waters of PRAIRIE CREEK, a tributary of WALLOWA RIVER, for the purpose of IRRIGATING 287.0 ACRES.

The right has been perfected under Permit 40278. The date of priority is APRIL 22, 1976. The right is limited to not more than 7.17 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SW 1/4 NE 1/4, SECTION 5, T 2 S, R 45 E, W.M.; 580 FEET NORTH & 510 FEET EAST FROM C 1/4 CORNER OF SECTION 5.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.5 acre-feet per acre for each acre irrigated during the irrigation season of each year. IN THE EVENT OF A REQUEST FOR A CHANGE IN POINT OF DIVERISON, ADDITIONAL POINT OF DIVERSION, CHANGE IN PLACE OR CHARACTER OF USE, THE QUANTITY OF WATER ALLOWED HEREIN TOGETHER WITH ANY EXISTING WATER RIGHTS FROM THIS POINT OF DIVERSION SHALL NOT EXCEED 8.2 CFS.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

TOWNSHIP 2 SOUTH, RANGE 45 EAST, W.M.	

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
