CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

WILLIAM S. ROBINSON HC 86, BOX 101 MYRTLE POINT, OREGON 97458

confirms the right to use the waters of EAST FORK COQUILLE RIVER, a tributary of COQUILLE RIVER, for the purpose of IRRIGATING 33.3 ACRES AND DOMESTIC USE FOR TWO FAMILIES INCLUDING THE IRRIGATION OF LAWN AND GARDEN NOT TO EXCEED ONE-HALF ACRE IN AREA.

The right has been perfected under Permit 40405. The date of priority is MARCH 5, 1976. The right is limited to not more than 0.43 CUBIC FOOT PER SECOND; BEING 0.42 CFS FOR IRRIGATION AND 0.01 CFS FOR DOMESTIC, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

NE 1/4 SW 1/4, SW 1/4 SE 1/4, SE 1/4 SE 1/4, SECTION 11, T 28 S, R 11 W, W.M.; 1140 FEET SOUTH AND 550 FEET WEST, 1740 FEET SOUTH AND 1640 FEET EAST, 2290 FEET SOUTH AND 1260 FEET EAST, ALL FROM C 1/4 CORNER SECTION 11.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

NE 1/4 SW 1/4 18.9 ACRES
SE 1/4 SW 1/4 0.2 ACRE
NW 1/4 SE 1/4 0.7 ACRE
SW 1/4 SE 1/4 10.5 ACRES
SE 1/4 SE 1/4 3.0 ACRES & DOMESTIC

SECTION 11 TOWNSHIP 28 SOUTH, RANGE 11 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
