CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

DON D. DODSON

confirms the right to use the waters of NORTH POWDER RIVER, a tributary of POWDER RIVER, for the purpose of PRIMARY IRRIGATION OF 17.9 ACRES, SUPPLEMENTAL IRRIGATION OF 54.0 ACRES AND LIVESTOCK.

The right has been perfected under Permit 45715. The date of priority is MAY 26, 1981. The right is limited to not more than 1.8 CUBIC FEET PER SECOND FROM MARCH 1 TO JUNE 30 AND 0.90 CFS FROM JULY 1 TO SEPTEMBER 30 FOR IRRIGATION AND SUPPLEMENTAL IRRIGATION AND 0.5 CFS FOR LIVESTOCK; or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NE 1/4 SE 1/4, SECTION 22, T 6 S, R 39 E, W.M.; 1890 FEET NORTH AND 840 FEET WEST FROM SE CORNER SECTION 22.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. The right shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein, provided further that during the irrigation season the water for livestock shall be a part of that diverted for irrigation and shall not at any time exceed 0.5 cfs.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

SECTION 14
TOWNSHIP 6 SOUTH, RANGE 39 EAST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
