CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of EAST FORK COQUILLE RIVER, a tributary of COQUILLE RIVER, for the purpose of IRRIGATING 155.9 ACRES.

The right has been perfected under Permit 37825. The date of priority is OCTOBER 14, 1974. The right is limited to not more than 1.95 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

LOT 5 (SE 1/4 NE 1/4), LOT 8 (NE 1/4 SW 1/4), SECTION 21, LOT 6 (SE 1/4 NW 1/4), SECTION 22, LOT 5 (NW 1/4 NW 1/4), SECTION 28, T 28 S, R 11 W, W.M.; 550 FEET NORTH AND 800 FEET WEST FROM E 1/4 CORNER SECTION 21, 300 FEET SOUTH AND 600 FEET WEST FROM C 1/4 CORNER SECTION 21, 340 FEET NORTH AND 1040 FEET WEST FROM C 1/4 CORNER SECTION 22, 1200 FEET SOUTH AND 900 FEET EAST FROM NW CORNER SECTION 28.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
