confirms the right to use the waters of LITTLE BUTTE CREEK, a tributary of ROGUE RIVER, for the purpose of IRRIGATING 10.2 ACRES.

The right has been confirmed by decree of the Circuit Court of the State of Oregon for JACKSON County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 14, at page 498. The date of priority is 1883.

The right is limited to not more than 0.20 CUBIC FOOT PER SECOND.

The point of diversion is located as follows:

SW 1/4 SE 1/4, SECTION 31, T 35 S, R 1 E, W.M.; 500 FEET NORTH AND 440 FEET EAST FROM S 1/4 CORNER SECTION 31.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FIFTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated during the irrigation season of each year.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered JUNE 9, 1967, and together with certificate 34845, supersedes certificate 33239, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and shall be subject to all other conditions and limitations contained in said decree.
