CERTIFICATE ISSUED TO

RICHARD D. HEVNER BOX 43 BROGAN, OREGON 97903

confirms the right to use the waters of WILLOW CREEK, a tributary of MALHEUR RIVER, for the purpose of THE SUPPLEMENTAL IRRIGATION OF 39.9 ACRES.

The right has been perfected under Permit 42210. The date of priority is APRIL 8, 1977. The right is limited to not more than 1.0 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source, if available at the original point of diversion, NE 1/4 NE 1/4, SECTION 25, T 15 S, R 42 E, W.M.; HEVNER DITCH - 140 FEET SOUTH AND 890 FEET WEST FROM NE CORNER SECTION 25.

The point of diversion is located as follows:

LOT 2 (SW 1/4 NW 1/4), SECTION 30, T 15 S, R 43 E, W.M.; 1340 FEET SOUTH AND 100 FEET EAST FROM NW CORNER SECTION 30.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. The right shall be limited to any deficiency in the available supply of any prior right for the same land and shall not exceed the limitation allowed herein.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered AUGUST 16, 1984, and together with certificate 52566 confirms the water right perfected under permit 42210.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
