## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

RICHARD GUERBER 27782 GUERBER LANE CORVALLIS, OREGON 97333

confirms the right to use the waters of WHITAKER LAKE AND WAGNER LAKE, tributaries of WILLAMETTE RIVER, for the purpose of IRRIGATING 197.5 ACRES.

The right has been perfected under Permit 43176. The date of priority is MAY 11, 1978. The right is limited to not more than 1.79 CUBIC FEET PER SECOND; BEING 0.20 CFS FROM WHITAKER LAKE AND 1.59 CFS FROM WAGNER LAKE, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

NE 1/4 SW 1/4, SECTION 14, NE 1/4 NW 1/4, SECTION 23, T 13 S, R 5 W, W.M.; WHITAKER LAKE - 460 FEET SOUTH AND 2440 FEET WEST FROM THE NE CORNER DLC 47; WAGNER LAKE - 550 FEET SOUTH AND 3250 FEET WEST FROM THE NE CORNER OF SECTION 23.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
