CERTIFICATE OF WATER RIGHT

This is to Certify, That JOHN F. DOBBIN

of Union, State of Oregon has a right to the use of the waters of Little Creek for Tract #1; Catherine Creek for Tract #2; for the purpose of Irrigation

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Union County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 8, at page 1; that the priority of the right thereby confirmed dates from 1872 for Tract #1; Nov. 1903 for Tract #2;

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed Three acre feet per acre in any irrigation season, diverted at a rate of not to exceed one-fortieth of a cubic foot per second per acre;

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:

Tract #1: Sixteen (16) acres in the Northeast Quarter of the Northeast Quarter (NE1/4NE1/4), Thirty-six (36) acres in the Northwest Quarter of the Northeast Quarter (NW1/4NE1/4), Twenty-two (22) acres in the Southwest Quarter of the Northeast Quarter (SW1/4NE1/4), Sixteen (16) acres in the Southeast Quarter of the Northeast Quarter (SE1/4NE1/4), Section Ten (10), Township 4 South, Range 39 East of the Willamette Meridian, being a total of 90 acres.

Tract #2: Seventeen and seventy-three hundredths (17.73) acres in the Northeast Quarter of the Northwest Quarter (NE1/4NW1/4), Two and seventy-five hundredths (2.75) acres in the Northwest Quarter of the Northeast Quarter (NW1/4NE1/4), Section Ten (10), Fifteen and ninety-three hundredths (15.93) acres in the Southeast Quarter of the Southwest Quarter (SE1/4SW1/4), Three and six tenths (3.6) acres in the Southwest Quarter of the Southeast Quarter (SW1/4SE1/4), Section Three (3), Township 4 South, Range 39 East of the Willamette Meridian, being a total of 40.01 acres.

Point of div changed for part of lands Sec. 5 or Vol. 1 p. 417 Amendments p. 11, Vol. 12, p. 14

And said right shall be subject to all other conditions and limitations contained in said decree.

The right to the use of the water for irrigation purposes is restricted to the lands or place of use herein described.
