CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of BEAVER CREEK, a tributary of CRABTREE CREEK, for the purpose of IRRIGATING 90.9 ACRES.

The right has been perfected under Permit 20841. The date of priority is NOVEMBER 2, 1951. The right is limited to not more than 0.62 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

LOT 7 (SW 1/4 NE 1/4), SECTION 7, T 11 S, R 1 W, W.M.; 240 FEET NORTH AND 370 FEET WEST FROM THE NE CORNER OF DLC 42.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
