confirms the right to use the waters of WILLOW CREEK AND RESERVOIR NO. 3, a tributary of MALHEUR RIVER, for the purpose of IRRIGATING 4.9 ACRES.

The right has been confirmed by decree of the Circuit Court of the State of Oregon for MALHEUR County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 9, at page 223. The date of priority is APRIL 7, 1908.

The point of diversion is located as follows:

COLE DITCH.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to a diversion of not to exceed 2.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

SE 1/4 SW 1/4 4.9 ACRES  
SECTION 14  
TOWNSHIP 15 SOUTH, RANGE 42 EAST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and shall be subject to all other conditions and limitations contained in said decree.

These rights are prior to the remaining rights under "New Form" contracts for 580.5 acres of land described by said decree, but subsequent and inferior to the rights under "Old Form" contracts for 533.43 acres of land described by said decree.

The quantity of water diverted under the rights tabulated herein together with the quantity diverted under any other water right shall not exceed 3.0 acre feet for each acre irrigated during any irrigation season.

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered AUGUST 10, 1981, and together with 62423, 62426, 62427, 62428, 62431, 62433, and 62434 supersedes certificate 45354, State Record of Water Right Certificates.
